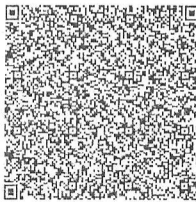

WHEREAS:

A.) First Party is a Higher Educational Institution named:

D.) The Parties will work together towards achieving the objective of Creating Farmers Community Based Institution, Farmer Producer Organisation on Nutri Cereal Development

E.) The Parties intent to cooperate and focus on their efforts on cooperation within area of skill based training, education and research in the field of the regenerative sustainable rainfed organic agriculture of different millet crops like Ragi, Jowar, Bajra, Kodo, Sanwa, Kutki, and Kakun.

F.) The Parties intent to cooperate and focus on their efforts on cooperation within area of Millets Promotion, conserving and propagation of millet crops

- G.) Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interests.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

Clause -1

Cooperation



- 1.1 Both parties are united by common interest and objectives, and they shall establish channels of communication and cooperation that will promote and advance their respective operations within the **institutions** and its related wings. The party shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.

1.2 First Party and Second Party Co-operation will facilitate effective utilization of the intellectual capabilities of faculty of the first party providing significant input to them in developing suitable teaching/ training systems, keeping in mind the need of the industries, the second party.

1.3 The general terms of cooperation shall be governed by this MOU. The parties shall cooperate with each other and shall, enter into all relevant agreements, deeds, documents (the definitive documents) as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

CLAUSE 2

SCOPE OF THE MoU

2.1 The budding graduates from the institutions could play a key role in technological up-gradation, innovation and competitiveness of an industry. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.

2.2 **Curriculum Design:** Second Party will give valuable inputs to the First Party in teaching / training methodology and suitably customize the curriculum so that the students fit into the industrial scenario meaningfully.

2.7 **Faculty Development Programs:** Second Party to train the Faculties of First Party for imparting training as per the industrial requirement considering the National Occupational Standards in concerned sector, if available.

2.8 **Placement of Trained Students:** Second Party will actively engage to help the delivery of the

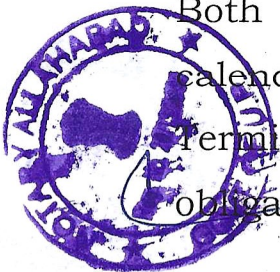

CLAUSE 4

VALIDITY

This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms, during which period **Triveni Agri Inputs, Prayagraj**, the Second Party, as the case may be, will take effective steps for implementation of this MOU. CLAUSE 5

RELATIONSHIP BETWEEN THE PARTIES

5.1 It is expressly agreed that First Party and Second Party are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or

Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.
